COCHRAN, WILLIAM W., Private, Company C. Mustered age 18 June 10, 1863. Younder brother of Captain John M. and George W. Cochran. During the Peninsula Campaign Battle for Williamsburg, Virginia, was sent forward by Major Gazzam to reconnoiter along with B. H. Scott. They discovered an officer's horse, fully caparisoned, recently deserted by its rider, standing a short distance in front of Fort Magruder. While Cochran stood guard, Scott captured the horse. This was the first regimental trophy. Had it not been for this action, the regiment would have been the first into the fort. Died in Plymouth, North Carolina January 6, 1864 of chronic diarrhea and was buried at New Bern National Cemetery, North Carolina Pl 7#1205.

At first, the pickets were driven back but Captain Gillespie rallied them and forced the Conferates back. Two days later when the 103rd, positioned north of Williamsburg Road was driven back, Captain Gillespie succeeded in keeping most of the men south of the road together and formed them to the right of Spratt's battery where they remained until the advance line was driven back. He, with two other officer, rallied the men at the intrenchments, where they remained until the entire force was driven back. Captain Gillespie was Killed In Action May 31, 1862, on the line where the last rally of Wessell's Brigade was made in advance of Couch's Division. He was shot through the breast and is buried in Seven Pines National Cemetery D500.

IRWIN, HIRAM, Private, Company H. Mustered February 22, 1862 - June 19, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40764. Left prison February 23, 1865.

IRWIN, PERRY, Private, Company H. mustered March 23, 1862 - September 17, 1863. Deserted from Plymouth, North Carolina.

IRWIN, WILLIAM H., Adjutant, Staff. Mustered January 10, 1862 - March 12, 1865. Promoted from 1st Lieutenant to Adjutant, November 29, 1862. Transferred from Company G. Captured in Plymouth, North Carolina April 20, 1864. Imprisoned in Charleston and Columbia, South Carolina. Left prison March 1, 1865 paroled at Wilmington, North Carolina.

JACKSON, ALEXANDER C., Private, Company B. Mustered September 24, 1861. Was prostrated in July 1862, with swamp fever, and was unable to continue service. Hospitalized at Brooklyn, New York until December 29, 1862 when he was honorably discharged.

JACKSON, ANDREW, Private, Company H. Mustered February 22, 1862 - March 1863.

JACOBS, THEODORE, Assistant Surgeon, Staff. Mustered November 19, 1861 - June 25, 1862. Resigned.

JAMESON, WILLIAM, Corporal, Company H. Mustered February 22, 1862 - March 15, 1865. Conflicting information: Captured in Plymouth, North Carolina April 20, 1864. Died August 2, 1864 and buried in Andersonville Code 14590. Admitted to Haddington US Army Hospital, Philadelphia, Pennsylvania August 23, 1864.

JAMISON, JOHN K., Private, Company E. Mustered February 29, 1864. Died April 6, 1864. Buried in Allegheny Cemetery, Pittsburgh, Pennsylvania.

JEWART, THOMAS, Private, Company G. Mustered January 10, 1862 - January 10, 1865. Transferred as teamster May 1, 1862.

JOHNSON, P., Private, Company F. Listed on tombstone as member of regiment having died September 20, 1864 and buried in Andersonville Code 19303.

JOHNSON, WILLIAM, Sergeant, Company H. Mustered February 22, 182. Killed In Action during Battle of Plymouth, North Carolina April 20, 1864.

JOHNSTON, DAVID, Private, Company F. Mustered December 7, 1861.

JONES, DANIEL, Private, Company E/F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40364.

JONES, JAMES M., Private, Company K. Mustered October 28, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40454. Died October 1, 1864 of chronic diarreara while imprisoned at Charleston Race Course. Buried at Beaufort National Cemetery.

JONES, JOHN L., Private, Company C. Mustered age 26, September 16, 1861 - September 16, 1864.

JONES, JOHN M., Private, Company B. Mustered September 24, 1861.Captured in Plymouth, North Carolina April 20, 1864. Died August 16, 1864 and buried in Andersonville Code 12593.

JOSEPH, NEWTON, Private, Company B. Mustered September 24, 1861. Killed In Action May 29, 1862 during Battle of Fair Oaks, Seven Pines, Virginia. Evidently died at close range as his forehead was crushed by a blow from a musket while on pickett line. First man in regiment killed by Conferate soldier. Buried at Seven Pines Cemetary, Seven Pines, Virginia.

JOSEPH, WILLIAM, Private, Company I. Mustered age 20, December 16, 1861. Died July 2, 1862 of typhoid in Washington DC. Buried in Military Asy. Cemetery, Washington, DC. #C3684.

JUDSON, ANDREW, Private, Company B. Mustered November 1, 1861. Transferred to 4th Artillery Regiment.

JUDSON, SMITH, Corporal, Company A. Mustered September 7, 1861 - June 25, 1865. Promoted to Corporal January 1, 1864. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41471. Left prison December 1864.

JUDY, FRANCIS, Private, Company H. Mustered February 22, 1862. Missing In Action May 31, 1862, during Battle of Fair Oaks/Seven Pines, Virginia.

JUSTICE, WILLIAM, Private, Company K. Mustered October 28, 1861. Wounded In Action, May 31, 1862, during Battle of Fair Oaks/Seven Pines, Virginia. Died August 19, 1862 in Philadelphia hospital from wounds.

KAEMERGER, HENRY W., Private, Company K. Mustered October 28, 1861. Died in Plymouth, North Carolina, February 19, 1864 of chronic diarrhea. Buried in New Bern, North Carolina Cemetery #1206.

KARNS, ANTHONY, Private, Company F. Mustered December 7, 1861.

KEEFER, WILLIAM D., Muscian/Private, Comany B/F. Mustered September 24, 1861 - June 25, 1865. Transferred to Company F December 31, 1863. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code unknown. Left prison February 26, 1865.

KEIFER, ANDREW S., Private, Company A. Mustered September 7, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40245. Left prison December 1864.

KEISTER, SIMEON H., Private, Company A. Mustered September 7, 1861. Detached to 7th NY Indpendant Battery and Artillery, Albany, New York from September 24, 1863 - July 22, 1865.

KETH, ALEXANDER, Private, Company F. Mustered December 7, 1861 - June 19, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40365. Left prison December 11, 1864.

KETH, GEORGE W., Private, Company F. Mustered December 7, 1861. Died in Clarion, Pennsylvania, July 31, 1862.

KELLY, GEORGE W., 1st Lieutenant, Company H. Mustered February 22, 1862 - February 21, 1865. Promoted to Captain November 1, 1863. On recruiting service April 1864.

KELLEY, JOHN A., Corporal, Company I. Mustered as youngest member of company at age 15, December 16, 1861 - June 25, 1865. Wounded In Action (flesh wound) May 31, 1862 during the Battle of Fair Oaks, Seven Pines, Virginia. Promoted to Corporal August 25, 1863. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40421. Imprisoned also at Charleston and Florence, South Carolina. Left prison March 1, 1865.

KELLEY, RICHARD, Private, Company B. Mustered September 24, 1861 - February 10, 1863. Discharged.

KELLEY, SAMUEL, Private, Company I. Mustered December 16, 1861 - December 27, 1862 in Baltimore, Maryland.

KENNEDY, DAVID A., Private Company C. Mustered age 28, September 16, 1861. Transferred to Signal Corps either November 1, 1862 or July 11, 1863.

KENNEDY, HAMILTON C., Private, Company E. Mustered December 7, 1861. Wounded In Action, June 27, 1862 during the Peninsula Campaign, Battle of Seven Days. "Was placed in ambulance in a dying condition June 27, 1862, and never afterwards seen by his comrades".

KENNEDY, HENRY, Private, Company H. Mustered February 22, 1862. Transferred to Veteran Reserve Corps.

KENNEDY, JOHN, Private, Company E. Mustered December 7, 1861 - June 12, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40786. Left prison February 27, 1865.

KENNEDY, SAMUEL B., Adjutant, Staff. Mustered December 5, 1861 to November 29, 1862. Protege of Colonel Lehmann, and was among the very first appointments made by the Colonel after assuming command. Appointment caused some friction among Company officers. Soon gained the good will of both officers and enlisted men. Accidentally wounded by a shot from a revolver in the hands of Captain Laughlin, at Suffolk, Virginia. Resulted in his discharge.

KENNEDY, SMITH, Corporal, Company G. Mustered age 27, January 10, 1862. Wounded In Action May 31, 1862 during Battle of Fair Oaks, Seven Pines, Virginia. Transferred to Veteran Reserve Corps.

KENNEDY, WILLIAM, Private, Company B. Mustered September 24, 1861. Died on Roanoke Island, North Carolina about the time of the Battle of Plymouth, North Carolina.

KERNS, ANTHONY, Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41549. Died and buried in Annapolis, Maryland National Cemetery, March 12, 1865.

KERR, PATRICK, Private, Company D. Mustered age 18, November 13, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40308. Left prison February 27, 1865.

KEYSER, EDWARD, Private, Company K. Mustered age 18, January 2, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40455.

KIER, SAMUEL A., Corporal, Company C. Mustered age 18, September 16, 1861 - June 25, 1865. Promoted to Corporal January 1, 1864.

KIESTER, EPAPHRODITUS, Private, Company I. Mustered December 16, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died July 20, 1864, and buried in Andersonville Code 13634.

KIESTER, JACOB S., Sergeant, Company I. Mustered age 28, December 16, 1861. Promoted to Corporal September 1, 1862 and to Sergeant January 1864. Wounded In Action December 14, 1862. Spent "short time" in hospital. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40420. Transferred to Charleston Prison and then to Florence Prison in

South Carolina. Died in Florence Prison November 23, 1864.

KIESTER, JOHN N., Private, Company A. Mustered September 7, 1861.Captured in Plymouth, North Carolina April 20, 1864. Died August 13, 1864, and buried in Andersonville Code 15718.

KIESTER, URIAH, Private, Company I. Mustered December 16, 1861 - May 11, 1865. Left Company I sick July 1, 1862, did not return and was carried as a deserter. Returned to regiment May 9, 1865 under President Lincoln's amnesty proclamation.

KIESTER, WILLIAM H., 1st Lieutenant, Company I. Mustered January 12, 1862 - June 25, 1865. Promoted to 2nd Lieutenant March 1, 1862, and to 1st Lieutenant June 30, 1862.Captured in Plymouth, North Carolina April 20, 1864. Escaped October 5, 1864 near Columbia, South Carolina. Recaptured October 16, 1864 Rutherford, North Carolina. Prisions included Charleston, South Carolina and Danville and Richmond (Libby Prison), Virginia. Left prison February 21, 1865.

KING, WILLIAM, Private, Company H. Mustered February 22, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code

KINGMORE, DAVID, Private, Company C. Mustered age 21 August 31, 1864. Never joined the company.

KISKADDEN, HORACE, Private, Company H. Mustered February 22, 1862 - April 18, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40404. Left prison February 28, 1865.

KISER, HARRISON, Private, Company H. Mustered February 22, 1862. Died April 10, 1862, of typhoid at Camp Casey, Virginia (near Newport News). Buried at Hampton National Cemetery #C1827.

KISSINGER, MICHAEL, Private, Company F. Mustered December 7, 1861 - June 30, 1862. Wounded In Action, May 31, 1862 during Battle of Fair Oaks, Seven Pines, Virginia.

KLECK, WILLIAM, Private, Company H. Mustered February 22, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40797. Left prison December 16, 1864.

KLINE, JAMES, Private, Company H. Mustered February 22, 1862. Possibly died at Mount Pleasant Hospital, Washington, DC June 7, 1862.

KLINGLER, PETER, Private, Company H. Mustered March 31, 1862 - June 20, 1865. Wounded In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40794. Transferred to prison in Florence, South Carolina. Escaped from Florence by bribery, but recaptured. Left prison March 2, 1865.

KNESS, HARVEY, Private, Company F. Mustered December 7, 1861 - December 7, 1864. Detached service as Teamster.

KNESS, MARTIN, Private, Company D. Mustered November 13, 1861 - April 1862.

KNESS, WILLIAM H., Private, Company D. Mustered age 21, November 13, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40309. Died of diesease in Annapolis, Maryland December 1, 1864.

KNOX, THOMAS, Private, Company K. Mustered October 28, 1861. Wounded In Action, May 31, 1862, during the Battle of Fair Oaks, Seven Pines, Virginia. Died of wounds June 10, 1862.

KOCH, JOHN, Private, Company K. Drafted January 31, 1864. Captured in Plymouth, North Carolina April 20, 1864. Died August 24, 1864, and buried in Andersonville Code 16711.

KREBS, ADOLPH, Included as an "Honorary Member". Was a sutler "Banker of the Regiment. Was "honest and upright, well supplied, never overcharged". Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41468. Suffered as a POW for nearly a year; ill for several months after parole.

KREMP, EDWARD, Private, Company A. Mustered February 2, 1862. Wound In Action, December 14, 1862 during Battle of Kinston, North Carolina. Captured in Plymouth, North Carolina April 20, 1864. Died July 16, 1864, and buried Andersonville Code 13471.

KREMP, JOSEPH, Corporal, Company A. Mustered September 7, 1861 - April 12, 1865. Promoted to Corporal August 15, 1862. Wounded In Action December 14, 1862 during Battle of Kinston, North Carolina. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40236. Left prison February 25, 1865.

KRON, JOHN R., Command Sergeant, Transferred from Company G. Mustered January 10, 1862 - June 20, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40386. Left prison December 14, 1864. Promoted from Private to Command Sergeant May 18, 1865.

KROSEN, WILLIAM B., 2nd Lietuenant, Company D/K. Mustered November 13, 1861 - July 12, 1862. Promoted to 2nd Lieutenant December 15, 1861. Wounded In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Resigned from wounds.

KRUG, DANIEL, 1st Sergeant, Company K. Mustered age 21, October 28, 1861 - June 25, 1865. Promoted to 1st Sergeant January 2, 1864. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41554. Escaped from Florence Prison, South Carolina by bribery and fled toward Tennessee mountains.

KUHN, ISAAC L., Private, Company G. Mustered January 10, 1862. Died of lung disease in hospital, Beaufort, North Carolina, March 21, 1864. Buried in New Bern, North Carolina National Cemetery plot # 1225.

KUSTON, E., Private, Not carried on regimental roll, but listed on tombstone having died July 20, 1864 and buried at Andersonville Code 13634.

LANDIS, JOSEPH R., Private, Company H. Mustered February 1862. Wounded In Action, December 14, 1862, during the Battle of Kinston, North Carolina. Transferred to Veteran's Reserve Corps.

LAFFERTY, JAMES E., Private, Company C. "Arrived at Company C July 21, 1864 without papers; absent sick Jarvis Hospital, Baltimore, Maryland June 25, 1865".

LANG, AARON W., Private, Company B. Mustered August 25, 1862 - July 5, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40800. Left prison February 26, 1865.

LANG, CHARLES C., Hospital Steward, Staff. Mustered September 16, 1861 - May 30, 1865. Transferred from Company C. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40233. Left prison March 30, 1865.

LAUGHLIN, THOMAS J., Command Sergeant, Staff. Mustered September 7, 1861. Promoted to Command Sergeant December 7, 1861. Transferred from Company A to Company G, and then to Staff the same day. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code unknown. Died November 4, 1864 enroute to Florence, South Carolina.

LAUGHLIN, JOHN M., 1st Lieutenant, Company A. Mustered May 1, 1862 - June 25, 1865. Promoted to 2nd Lieutenant June 12, 1862 and to 1st Lieutenant January 25, 1863. Captured in Plymouth, North Carolina April 20, 1864. Escaped prison, but was recaptured. Eventually left prison March 1, 1865.

LAUGHLIN, REYNOLDS, Captain, Company A. Mustered September 7, 1861, but resigned January 24, 1863 because of age = 56 years.

LAUGHRIN, TERRENCE, Private, Company K. Mustered October 28, 1861.

LAWRENCE, DAVID W., Private, Company G. Mustered January 10, 1862. Discharged in New Bern, North Carolina during 1863.

LAWRENCE, ETHELBERT, Private, Company H. Mustered February 22, 1862. Transferred to 4th US Regiment Artillery.

LECKY, JACOB, Private, Company A. Mustered September 7, 1861 - November 16, 1861.

LEECH, WILLIAM, Corporal, Company C. Mustered age 26, September 16, 1861. Transferred to Veteran Reserve Corps, December 1, 1863.

LEHMANN, THEODORE F., Colonel, Staff. Born in Germany, attended military academy serving as officer until 1833. Mustered July 1, 1861 - June 25, 1865. Promoted to Colonel October 3, 1861. Transferred from 62nd Pennsylvania Volunteers. Because of being thrown from his hourse during a collision wiht a sutler's wagon, he was not in command during the Battleof Fair Oaks, Seven Pines, Virgina. During the Battle of Plymouth, North Carolina, he

commanded the center of the line around the town.

LEISURE, GEORGE W., Private, Company D. Mustered age 37, November 13, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40310. Left prison April 29, 1865.

LEPLY, CHARLES, Private, Company E. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died September 11, 1864 and buried Andersonville Code 18405.

LESLIE, JOHN, Private, Company G. Mustered age 19, January 10, 1862. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40387. Left prison March 1, 1865. Died March 3, 1865, in General Hospital #4, Wilmington, North Carolina after entering Federal lines.

LINDSEY, AMOS, Private, Company K. Mustered age 22, October 28, 1861. Deserted June 27, 1862.

LINSENBIGLER, JACOB, Private, Company C. Mustered age 17, September 16, 1861 - March 23, 1863.

LOBAUGH, JAMES H., Private, Company A. Mustered September 7, 1861 - January 20, 1863.

LOGAN, SAMUEL, Sergeant, Company E. Mustered age 20, December 7, 1861. Killed In Action, April 20, 1864, during the Battle of Plymouth.

LOGUE, CLARION J., Private, Company A. Mustered March 9, 1864 - June 25, 1865.

LOGUE, DAVID, Private, Company A. Mustered March 3, 1864. Died May 9, 1864, and buried in Philadelphia, Pennsylvania.

LOGUE, JOHN H., Private, Company A. Mustered March 3, 1864. Never joined the company.

LOGUE, OLIVER R., Private, Company A. Mustered March 9, 1864 - June 25, 1865

LOLL, JOHN, Private, Company H. Mustered February 22, 1862. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Died July 10, 1862 from wounds in Washington, DC and buried in Military Assembly Cemetery #C3708.

LORE, EMANUEL, Private, Company C. Mustered age 21, September 16, 1861 - June 25, 1865.

LOUGHNER, EDWARD W., Private, Company A. Mustered September 7, 1861. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Again Wounded In Action December 14, 1862. Died December 18, 1862 of wounds.

LOUGHNER, JOHN, Private, Company A. Mustered September 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41480. Died May 8, 1865, in Annapolis Camp Parole Hospital, and buried in Annapolis National Cemetery #871.

LOVE, WILLIAM M., Private, Company G. Mustered age 34, January 10, 1862 - June 25, 1865.

LOVE, WILLIAM W., Private, Company G. Mustered January 10, 1862 - June 14, 1862.

LOW (LEW), JOHN, Sergeant, Company C. Mustered September 16, 1861 - September 16, 1864. Promoted to Corporal September 16, 1861 and to Sergeant April 14, 1863.

LOWER, JOHN, Private, Company H. Mustered February 22, 1862 - June 6, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40809. Left Charleston, South Carolina prison December 10, 1864.

LOWTHERS (LOWERS), JOHN, Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40366.

LUTHER, ENOCH, Corporal, Company A. Mustered September 7, 1861 - April 7, 1863 (discharged). Promoted to Corporal August 15, 1862.

LUTHER, GEORGE W., Private, Company A. Mustered age 18, March 3, 1864. Died October 15, 1864, Roanoke Island, North Carolina of typhoid.

LYTLE, JAMES S., Private, Company I. Mustered age 33, December 16, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40437. Left prison December 22, 1864. Died the "night he reached home"
