MACK, GEORGE, Private, Company D. Mustered March 14, 1865 - June 25, 1865.

MACKEY, JAMES F., Major, Headquarters Staff. Mustered February 22, 1862 - March 12, 1865. Promoted to Captain November 1, 1863, and to Major December 15, 1864. Fought in all campaigns from Williamsburg, Virginia to Plymouth, North Carolian. Captured in Plymouth, North Carolina April 20, 1864. Held at Andersonville Church, Macon, Georgia, Charleston, and Columbia, South Carolina. Left prison March 1, 1865. Died May 11, 1883 in Franklin, Pennsylvania.

MacKIM, WILLIAM, Private, Company E. Died August 8, 1864, and buried Andersonville Code 15016.

MAHOOD (MAYHOOD), JOHN, Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 43232 or 40368. Died of chronic diaherra December 14, 1864, Charleston Race Course prison, South Carolina. Monument at New Bern, North Carolina lists J. Mayhood as reinterred at Beaufort National Cemetery. All buried there are listed as "unknown".

MAJOR, WILLIAM, Private, Company I. Mustered December 16, 1861. Wounded In Action December 14, 1862, during Battle of Kinston, North Carolina. Captured in Plymouth, North Carolina April 20, 1864. Died July 22, 1864, and buried Andersonville Code 13793.

MANGEL, JOSEPH, Private, Company E. Mustered age 21, December 7, 1861 - May 26, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40340 until September 10, 1864, then held under fire at Charleston, South Carolina for 20 days, thence to Florence, South Carolina; and finally to Richmond, Virginia when he was parolled in February 1865. Discharged May 1865, at New Bern, North Carolina.

MANNON, JOHN, Private, Company H. Mustered February 22, 1862.

MAPES, JOSEPH C., 1st Sergeant, Company K. Mustered October 28, 1861. Wounded In Action December 14, 1862, during Battle of Kinston, North Carolina. Died of wounds December 29, 1862, at New Bern, North Carolina. Buried at New Bern National Cemetery.

MARSH, ADAM H., Private, Company F. Mustered December 7, 1861. Fell from train enroute to Harrisburg, Pennsylvania. Died February 24, 1862, in Pittsburgh, Pennsylvania.

MARSHALL, DAVID M., Assistant Surgeon, Staff. Mustered August 6, 1862. Transferred to 167 Pennsylvania Veterans Reserve January 28, 1863. Promoted to Surgeon same day.

MARTIN, ISAAC A., Private, Company E. Mustered December 7, 1861. Died November 23, 1862, of fever in Suffolk, Virginia. Buried at Hampton National Cemetery, Virginia #A3343.

MARTIN, JAMES, Private, Company H. Mustered February 22, 1862. Deserted.

MARTIN, JAMES Jr., Private, Company E. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died August 8, 1864, and buried Andersonville Code 15068.

MARTIN, JOHN, Private, Company D. Mustered September 25, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died August 22, 1864, and buried Andersonville Code 16480.

MARTIN, JOHN, Private, Company H. Mustered February 22, 1862. Deserted. "Never left home."

MARTIN, SAMUEL, Captain, Company E. Mustered December 7, 1862. While the Battle of Fair Oaks, Seven Pines, Virginia was raging, May 31, 1862, was carried from his tent due to illness. Died a week later, June 8, 1862 from disease.

MARTIN, WILLIAM H., Sergeant, Company E. Mustered age 42, December 7, 1861 - 1863.

MAUL, ALEXANDER, Private, Company G. Mustered January 10, 1862. Reported by comrades as Killed In Action, Williamsburg, Virginia.

MAYBERRY, ALBERT G., Private, Company I. Mustered December 16, 1861 - early 1862 (Discharged).

MAYER, THOMAS, Private, Company E. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died June 9, 1864, and buried Andersonville Code 11747.

MAYNARD, JOHN, Private, Company G. Mustered January 10, 1862. Captured January 22, 1864, while on reconnaissance. Imprisoned at Andersonville. Died of pneumonia March 27, 184, and buried Andersonville National Cemetery Code 10183.

MAXWELL, JAMES M., Private, Company I. Mustered December 16, 1861. Died May 4, 1862, at Camp Winfield Scott (near Yorktown, Virginia). Removed to Prairie Cemetery, Harrisville, Pennsylvania. Brother of Lt. Colonel Wilson C. Maxwell.

MAXWELL, WILSON C., Lt. Colonel, Staff. Mustered December 16, 1861 - December 15, 1864. Promoted from Captain March 1, 1862. Commanded regiment at Battle of Kinston in December 1862; the Expedition to Harresllsville, Hertford County, North Carolina, January 20, 1864; expedition to Bertie County January 26, 1864; and Battle of Plymouth, April 17 - 20, 1864. Transferred from Company I, April 20, 1864 - Novemer 1, 1864. Died shortly after discharge. Buried in Prairie Cemetery, Harrisville, Pennsylvania.

MAZE, ANDREW J., Corporal, Company H. Mustered February 22, 1862. Captured in Plymouth, North Carolina April 20, 1864. Died September 5, 1864, and buried Andersonville Code 17925.

MAZE, JOHN H., Private, Company H. Mustered February 22, 1863 - February 23, 1865. Transferred to Veterans Reserve Corps September 16, 1863.

McANALLON (McANAILAN), JOSEPH (JAMES) PERRY, Private, Company I. Mustered December 16, 1861 - March 28, 1863.

McANALLON, PATRICK, Private, Company I. Mustered December 16, 1861. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Died July 15, 1862, of wounds and typoid fever at Harrison's Landing, Virginia.

McANNALLON, JOHN, Corporal, Company I. Mustered December 16, 1861 - February 27, 1863.

McANNICH, HENRY, Private, Company D. Mustered November 13, 1861 - April 1862.

McBRIDE, PATRICK, Private, Company G. Mustered January 10, 1862. Died July 8, 1862, or July 24, 1863, and buried Cypress Hill Cemetery, Long Island, New York.

McBRIDE, SAMUEL F., Private, Company E. Mustered age 19, December 7, 1861. Transferred to Hospital Steward Regular Army December 4, 1862.

McBRIDE, WILLIAM, Sergeant, Company I. Mustered age 32, December 16, 1861 - June 21, 1865. Wounded In Action during Battle of Plymouth, North Carolina. Shot through the throat and left on field of battle as mortally wounded. Recovered and was captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40419. Left prison in Savannah, Georgia November 30, 1864.

McCALL, OLIVER, 2nd Lieutentant, Company A. Mustered September 7, 1861 - March 30, 1865. Wounded In Action, December 14, 1862 during the Battle of Kinston, North Carolina. Promoted from 1st Sergeant January 25, 1863. Captured in Plymouth, North Carolina April 20, 1864. Escaped from Charleston, South Carolina November 4, 1864, but was recaptured.

McCALL, ROBERT C., Corporal, Company A. Mustered September 7, 1861 - February 20, 1863. Discharged.

McCALL, SYLVESTER, Private, Company A. Mustered September 7, 1861 -

June 25, 1865. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41481. Left prison December 1864.

McCANDLES (McCANDLESS), JOSIAH L., Sergeant, Company E. Mustered age 22 December 7, 1861. Died in 1862.

McCANDLESS, SAMUEL B., Private, Company E. Mustered age 20, December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40342. Died September 28, 1864, Charleston prison, South Carolina.

McCARRIER, JOHN N., Sergeant, Company E. Mustered December 7, 1861 - June 25, 1865. promoted to Sergeant January 2, 1864. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40322. Left prison December 14, 1864.

McCAY, DAVID, Chaplain, Staff. Mustered February 22, 1862 - May 17, 1862. Died June 1862 of typhoid at Lewistown, Pennsylvania enroute home. Buried in Callensburg, Pennsylvania.

McCAY, JOSEPH, Private, Company B. Mustered September 24, 1861. Died June 3, 1862, and buried at National Cemetery, Yorktown, Virginia #1338.

McCAY, MATTHEW J., Private, Company B. Mustered September 24, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died June 24, 1864, and buried Andersonville Code 12411.

McCLAIN, JOHN, Corporal, Company D. Mustered age 22, September 25, 1861 - June 3, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40290.

McCLEARY, JAMES K., Private, Company I. Mustered December 16, 1861. Wounded In Action December 14, 1862, during Battle of Kinston, North Carolina. Died March 7, 1863, of wounds in New Bern, North Carolina.

McCLEARY, ROBERT, Private, Company B. Mustered December 1, 1861. Killed In Action, May 31, 1862, during the Battle of Fair Oaks, Seven Pines, Virginia.

McCLUNG, CHARLES H., 1st Sergeant, Company E. Mustered December 7, 1861. Promoted to Sergeant December 7, 1861 and to 1st Sergeant October 28, 1862. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40321. Died October 16, 1864, in Florence prison, South Carolina.

McCLUNG, JOHN, Private, Company K. Mustered February 1, 1862. Killed In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia.

McCLURE, HARVEY B., Private, Company B. Mustered September 24, 1861. Captured in Plymouth, North Carolina April 20, 1864. Believe imprisoned, Andersonville. Died March 15, 1865, and buried at Camp Parole Hospital Cemetery, Annapolis, Maryland. #154N.

McCLURE, THOMAS L., Private, Company B. Mustered September 24, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41490. Died December 5, 1864, on transport BALTIC enroute to Annapolis, Maryland. Buried US General Hospital Cemetery, Annapolis, Maryland. #K841.

McCLUSKEY, WILLIAM C., Private, Company G. Mustered age 23, January 10, 1862. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40389. Died October 1864, in Charleston, South Carolina enroute to prison in Florence, South Carolina.

McCONKEY, JAMES, Private, Company C. Mustered September 16, 1861 - September 16,1864.

McCOOL, Wesley, Private, Company B. Mustered September 24, 1861 - May 3, 1863.

McCOY, ANDREW J., Corporal, Company I. Mustered age 30, December 16, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40422. While in prison at Florence, South Carolina, toes became frozen requiring amputation -- also contracted typhoid fever. In February 1865, was carried out of the stockade and placed near the railroad to be sent to the parole point. The train left, leaving him beside the track, as he was too weak to walk. From that time, he became unconscious and remained so until June 1865 at the General Hospital, Davis Island, New York.

McCOY, CALVIN, Private, Company I. Mustered December 16, 1861. Wounded In Action December 14, 1862, during the Battle of Kinston, North Carolina and

died December 16, 1862.

McCOY, DAVID, Corporal, Company I. Mustered December 16, 1861 - June 22, 1862. Possibly died at Hospital Bottoms Bridge, Virginia of malarial fever.

McCOY, JACKSON, 1st Sergeant, Company I. Mustered December 16, 1861 - June 25, 1865. Promoted to Sergeant December 16, 1861; to 1st Sergeant June 23, 1862 at White Oak Swamp, Virginia, and to 2nd Lieutenant July 10, 1863. Wounded In Action December 14, 1862, during Battle of Kinston, North Carolina (bullet entered belt, not wounded). Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40819. Left Florence prison, South Carolina December 22, 1864.

McCOY, JAMES, Private, Company F. Mustered December 7, 1861 - August 1, 1862 (Discharged).

McCOY, JOHN L., Private, Company A. Mustered March 8, 1864. Died of typhoid June 8, 1865 and buried in National Cemetery, New Bern, North Carolina.

McCOY, SAMUEL, Corporal, Company H. Mustered March 23, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40821. Left prison February 24, 1865.

McCOY, THOMAS J., Private, Company I. Mustered age 29, December 16, 1861 - June 25, 1865. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Spent 6 weeks in hospital. Rejoined regiment and was captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40439. Also imprisoned in Charleston and Florence, South Carolina.

McCROSKEY, JAMES, Private, Company C. Mustered age 34, September 16, 1861 - September 16, 1864.

McCRUM, WILLIAM C., 1st Lieutenant, Company I. Mustered December 16, 1861 - April 11, 1862. Resigned. Protege of Colonel Lehmann, originally from Pittsburgh, Pennsylvania and regarded as "interloper" by enlisted men.

McCULLOUGH, ANDREW, Private, Company G. Mustered age 19, January 10, 1862.

McCULLOUGH, WILLIAM, Private, Company G. Mustered age 19, January 10, 1862

MccURDY, JOHN W. C., Private, Company K. Mustered age 18, February 1, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41558. Left prison December 16, 1864.

McDONALD, ELIJAH H., Private, Company I. Mustered December 16, 1861. Killed In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia.

McDOWELL, MATHEW B., Captain, Company F. Mustered December 7, 1861 - June 21, 1862. Resigned due to illness.

McELFRESH, WILLIAM, Sergeant, Company C. Mustered age 17, September 16, 1861 - June 25, 1865. Promoted to Corporal January 1, 1864 and to Sergeant March 1, 1865.

McELHANY, JOHN S., Corporal, Company B. Mustered September 24, 1861 - April 24, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40259. Left prison February 24, 1865.

McELHANY, WILLIAM, Sergeant, Company F. Mustered December 7, 1861. Killed In Action, December 14, 1862, during the Battle of Kinston, North Carolina.

McELHATTEN, JOHN, Private, Company H. Mustered February 22, 1862.

McELPHATRICK, DAVID, Private, Company I. Mustered December 16, 1861 - November 4, 1862. Died in 1907.

McELPHATRICK, ROBERT M., Private, Company I. Mustered December 16, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40438. Also imprisoned in Charleston and Florence, South Carolina. Left prison December 1864. Killed by a fall from an oil derrick circa 1890.

McELROY, HUGH, Private, Company E. Mustered age 40, December 7, 1861. Missing In Action, June 29, 1862, during Seven Days Battle, Peninsula Campaign.

McFARLAND, JOHN, Private, Company K. Mustered age 19, January 5, 1862. Deserted.

McGARRAH (McGARRACK), ROBERT W., Corporal, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died March 21, 1865 and buried Andersonville Code 12806.

McGEARY (McGARY), WILLIAM, Corporal, Company G. Mustered January 10, 1862 - June 25, 1865. Promoted to Corporal January 2, 1864. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40378. Left prison December 7, 1864.

McGEE, JAMES, Private, Company I. Mustered December 16, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died July 28, 1864, and buried Andersonville Code 14123.

McGILL, HELM J., Private, Company I. Mustered December 16, 1861 - August 11, 1864. Absent due to illness at Hammond General Hospital, Beaufort, North Carolina during Battle of Plymouth, North Carolina. Recorded as dying September 11, 1864, at Andersonville Code 18469.

McGREGOR, JOSEPH, Private, Company F. Mustered December 7, 1861 - June 17, 1862 (Discharged).

McGUIRE, JOSEPH, Private, Company C. Mustered age 16, September 16, 1861 - December 24, 1861. Deserted from Camp Orr, Kittanning, Pennsylvania.

McGUIRK, JOHN, Private, Company I. Mustered December 16, 1861 - April 13, 1865. Did not re-enlist at Plymouth, North Carolina. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40440. Also imprisoned at Charleston and Florence, South Carolina. Left prison December 10, 1864.

McINTYRE, FRANKLIN, Private, Company K. Drafted January 31, 1864. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code :40456.

McINTIRE, JOSEPH, Private, Company C. Mustered February 1, 1862. Died August 24, 1862 in hospital, Philadelphia, Pennsylvania.

McKAIN, JAMES, Sergeant, Company I. Mustered age 22, December 16, 1861. Promoted to Sergeant as a result of being a good drillmaster at organization of company, Camp Orr, Kittanning, Pennsylvania.

McKEE, CYRUS K., Sergeant, Company B. Mustered September 24, 1861. Wounded In Action December 14, 1862, during the Battle of Kinston, North Carolina. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40257. Died and buried December 7, 1864, at Charleston Race Course (Prison), South Carolina. Soldiers names on monumnet reinterred at Beaufort National Cemetery from the Charleston Race Course include C. R. McKee PA. All these soldiers buried as unknown.

McKEE, GEORGE W., Private, Company C. Mustered September 16, 1861 - September 16, 1864.

McKEE, THOMAS J., Corporal, Company C. Mustered September 16, 1861 - September 16, 1864. Wounded In Action December 16, 1862 during the Battle Of Kinston, North Carolina. Promoted to Corporal November 1, 1863.

McKILLIP (McKILLIPS), WILLIAM M., Private, Company C. Mustered age 17, September 16, 1861 - June 25, 1865.

McLAFFERTY, JOHN, Private, Company D. Mustered November 13, 1861 - August 1, 1862 (Discharged).

McLAUGHLIN, JAMES P., Private, Company I. Mustered December 16, 1861. Died of yphoid May 10, 1862, at Washington, DC. Buried at Military Assembly, Cemetery, Washington, DC.

McNANNY (McMANNY), MICHAIL, Private, Company F. Mustered December 7, 1861. Wounded In Action, May 31, 1862.

McNARY, OLIVER R., QuarterMaster, Staff. Enlisted as Private in Company F, 12th Pennsylvania for three months, April 17, 1861. April 27, 1861, was appointed Orderly-Sergeant. Declined appointment as Captain and Assistant-Quartermaster, but at request of the Secretary of War and Quartermaster General, served as Post Quartermaster until February 1862. Mustered March 1, 1862. Wounded and captured in Plymouth, North Carolina April 20, 1864. Also confined at Macon and Savannah, Georgia, Charleston and Columbus, South Carolina. Exchanged in December 1864 arriving at Annapolis Hospital weighing 74 pounds. Never returned to regiment. After parole, carried as "detached

service" at Madison Wisconsin, Raleigh, North Carolina. Mustered out October 1865 as Brevet Major; was three times wounded in action.

McNEES, MATTHEW, Private, Company I. Mustered December 16, 1861. Wounded In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Died from wounds July 3, 1862, in Annapolis, Maryland. Buried in Annapolis National Cemetery #1892.

McNEES, SAMUEL, Private, Company I. Mustered December 16, 1861 - August 3, 1862.

McPHERSON, DAVID, Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died August 17, 1864 and buried Andersonville Code 16014.

McPHERSON, THEODORE, Private, Company H. Mustered April 30, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40405.

McSORLEY, JAMES, Private, Company I. Mustered December 16, 1861. Was a Mexican War veteran. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 30202.

MEASLES, JAMES E., Died August 8, 1864, Andersonville Code 15009 Or 15069.

MECHLING, WILLIAM SLYVESTER, Private, Company E. Mustered age 24, December 7, 1861 - March 15, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code unknown. Died 1893 and buried Glade Run Cemetery, Dayton, Pennsylvania.

MEEGERS, DAVID, Private, Company D. Died on board USS Transport "Northern Light" December 13, 1864.

MEEKER, ALBERT, Sergeant, Company A. Mustered September 1, 1861 - April 12, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40235. Left prison February 25, 1865.

MEKLY, U.A., Private, Company I. Died December 22, 1864, at Camp Parole, Annapolis, Maryland.

MEREDITH, JOHN Q. A., Surgeon, Staff. Mustered July 1, 1862 - June 25, 1865. Promoted to Surgeon March 23, 1865. Captured in Plymouth, North Carolina April 20, 1864. Forced to stay in prison for several months, with the Officers, as if he were a combatant.

MEREDITH, MADISON M., Captain, Company D. Mustered November 13, 1861 - July 13, 1862. Promoted from 1st Lieutenant April 10, 1862. Resigned due to illness. Died April 19, 1904, Grand View Sanitarium, Wernersville, Pennsylvania at age of 72.

MEREDITH, THOMAS A., Private, Company C. Mustered September 16, 1861. Killed In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia.

MERIKEL, JOSEPH S., Private, Company D. Mustered November 13, 1861 - 1862.

METZLER, BARNHART, Private, Company D. Mustered November 13, 1861. Died October 12, 1863, in Plymouth, North Carolina. Buried in New Bern National Cemetery #1166, New Bern, North Carolina.

MILLER, FOWLER, Private, Company I. Mustered December 16, 1861. Killed In Action, May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia.

MILLER, GEORGE W., Private, Company A. Mustered September 7, 1861 - December 7, 1861.

MILLER, JAMES P., Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 41550. Died November 30, 1864, in Annapolis, Maryland. Buried at Annapolis National Cemetery #B2069.

MILLER, JOHN, Private, Company G. Mustered January 10, 1862 - July 14, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40388. Left prison April 1, 1865. 1890 Census, Comanshanne Township, Armstrong County, Pennsylvania indicates 12 months captivity in Andersonville.

MILLER, JOHN W., Mustered December 16, 1861. Went to hospital and never heard from (Deserted).

MILLER, WILLIAM, Private, Company E. Mustered December 7, 1861 - January 17, 1862 (Camp Orr, Kittanning, Pennsylvania).

MILLER, WILLIAM R., Private, Company A. Mustered March 3, 1864 - June 25, 1865.

MILLS, LORENZO F., Private, Company D. Mustered August 30, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864, Andersonville Code 40311. Left prison December 16, 1864.

Captured in Plymouth, North Carolina April 20, 1864. Escaped from Charleston Prison, South Carolina during the fall of 1864. Recaptured by October 29, 1864. Was also imprisoned in Columbia, South Carolina.

Served in Wilderness, Spottsylvania, Cold Harbor, Siege Petersburg, Sailor's Creek, Surrender Lee's Army.

Assisted Sutler "one Of the boys - frequently accompanied them on expeditions carrying a musket; Narrowly escaped capture on the Peninsula, Virginia when JEB Stuart made his raid -- coming up with the supplies and hearing the Confederte, he hid wagon in copse of trees. Was at Plymouth, North Carolina when the attack was made, but left to bring up some stores. Was prevented from returning due to success Of the ram Albemarle."

This caused the pickets to retire quickly despite General McClellan's (who was not near the battle) report that the pickets did not make a stand. Resigned because of illness.

WALTERS, THOMAS J., Sergeant, Company K. Mustered age 19, October 28, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864 Andersonville Code 40445. August 31, 1864 Regimental Headquarters, Roanoke Island, North Carolina reported that he arrived or whereabouts known.

WALTON, JOHN T., Assistant Surgeon, Staff. Mustered March 18, 1863 - June 19, 1865. Captured in Plymouth, North Carolina April 20, 1864 Andersonville Code unknown. Left prison October 1864. Promoted to Surgeon June 19, 1865. Transfered to 78th Pennsylvania Infantry Regiment June 19, 1865.

WARD, P., Company I. Imprisoned, died, and buried at Andersonville Code :14828.

WARNER, ISAAC W., Corporal, Company C. Mustered age 19, September 16, 1861 - June 20, 1863. Promoted from Private May 1, 1862.

WARNER, JETHRO, Private, Company G. Mustered January 10, 1862 - January 10, 1865. Absent on detached service in a battery of artillery during the Battle Of Plymouth, North Carolina. Reassigned to regiment in 1864.

WARNER, LESTER R., Private, Company H. Mustered February 22, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 41023. Left prison December 10, 1864.

WATERSON, PETER D., Private, Company H. Mustered February 22, 1862. Transfered to Veteran's Reserve Corps.

WATSON, DUNKLE, Company A. Was among the sick Pennsylvania and New Jersey troops arrived Saturday, June 14, 1862, at New York from the Peninsula Campaign.

WATSON, THOMAS J., Private, Company A. Mustered September 7, 1861. Died April 14 (10), 1862, during the Peninsula Campaign. Buried at Hampton National Cemetery, Virginia.

WATSON, ROBERT M., Corporal, Company C. Mustered age 18, September 16, 1861 - June 25, 1865. Wounded In Action December 14, 1862, during the Battle of Kinston, North Carolina. Promoted from Private March 1, 1865.

WATTERSON, GEORGE, Corporal, Company B. Mustered September 24, 1861 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40258. Left prison December 10, 1864. Promoted from Private May 1, 1865.

WATTERSON, WILLIAM B., Private, Company F. Mustered December 7, 1861 - June 2, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40372. Left prison April 21, 1865.

WEAKLY, HUGH ALEXANDER, Private, Company I. Mustered December 16, 1861. Wounded In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40444. Also imprisoned at Charleston Race Course and Florence, South Carolina. Died shortly after parole at Camp Parole, Maryland December 24 (22), 1864.

WEAVER, JACOB, Corporal, Company A/G. Mustered September 7, 1861. Transferred from Company A January 3, 1862. Wounded In Action, May 31, 1862, during the Battle of Fair Oaks, Seven Pines, Virginia.

WEAVER, JACOB, Private, Company K. Mustered October 30, 1861. Died and buried in Philadelphia, Pennsylvania August 21, 1862.

WEAVER, JOHN T., Private, Company G. Mustered age 17, January 10, 1862. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40343. Died of Chronic Diarreha January 25, 1865, in Florence Prison, South Carolina. Buried in National Cemetery, Florence, South Carolina.

WEBER, HENRY, Private, Company E. Mustered December 7, 1861. Died of Measles March 29 or April 1, 1862, in Washington, DC. Buried in Military Asy. Cemetery, Washington, DC #C2327.

WEBB, JOHN M., Private, Company E. Mustered December 7, 1861 - April 13, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 41005. Left prison February 25, 1865.

WEISENSTINE, PETER, 2nd Lieutenant, Company E. Mustered December 7, 1861 - December 8 (9), 1863. Promoted from Private October 28, 1862. Resigned.

WELCH, MARTIN, Private, Company D. Mustered September 25, 1861 - June 25, 1865. Wounded In Action May 31, 1862, during Battle of Fair Oaks, Seven Pines, Virginia and December 14, 1862, during the Battle of Kinston, North Carolina. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40319. Left prison November 30, 1864.

WELSH, PATRICK, Private, Company C. Mustered age 18, September 14, 1864 - June 25, 1865.

WENNER, MICHAEL, Private, Company F. Mustered August 25, 1862. Killed In Action December 14, 1862, during the Battle of Kinston, North Carolina.

WEST, RICHARD, Private, Company I. Mustered March 31, 1864 - June 25, 1865. Cook (African-American). Captured in Plymouth, North Carolina April 20, 1864. Was not in uniform and not sent to prison. Taken as a prisoner to Rainbow Banks, Roanoke River near Hamilton, North Carolina to work on Fort Branch fortifications. At first opportunity, rejoined the regiment.

WETZEL, GEORGE H., Private, Company H. Mustered February 22, 1862. Killed In Action December 14, 1862, during the Battle of Kinston, North Carolina.

WHEELER, WILLIAM, Private, Company D. Mustered November 13, 1861. Killed In Action December 14, 1862, during Battle of Kinston, North Carolina.

WHITACRE, ANDREW, Private, Company G. Mustered February 24, 1864 - June 25, 1865.

WHITACRE, ROBERT, Sergeant, Company G. Mustered age 19, January 10, 1862. Promoted to Sergeant January 2, 1864. Captured in Plymouth, North Carolina April 20, 1864 Andersonville Code 40374. Left prison March 1, 1865.

WHITE, DANIEL (DAVID), Private, Company G. Mustered January 10, 1862. Died "in service".

WHITE, EDWARD W., Private, Company K. Mustered February 1, 1862 (December 2, 1861). Captured in Plymouth, North Carolina April 20, 1864. Died August 29, 1864, and buried Andersonville Code 17277.

WHITE, JOHN H., Sergeant, Company F. Mustered December 7, 1861 - June 7, 1865. Captured in Plymouth, North Carolina April 20, 1864 Andersonville Code 40351. "I escaped from Andersonville in April 65 and after covering pretty Nearly all of the State of Georgia, finally struck Wilson's Cav. and stayed with

them until Lee's men commenced to come back. I succeeded in getting a Rebel uniform and flunked in with some returning Rebels, and played off as a Reb. I drew rations at Kirby's Smith camp, and finally reached Dalton, Ga. about a Month after I made my escape."

WHITE, MICHAEL, Private, Company B. Mustered September 24, 1861 - May 8, 1865. Captured in Plymouth, North Carolina April 20, 1864.
Andersonville Code 40284. Left prison March 18, 1865.

WHITEHILL, JOSEPH M., Sergeant, Company A. Mustered September 7, 1861 - June 17, 1865. Promoted from Private January 1, 1864. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40234. Left prison February 24, 1865.

WHITMAN, WILLIAM, Private, Company A. Mustered September 7, 1861 - November 1, 1861. Discharged from Camp Orr, Kittanning, Armstrong County, Pennsylvania.

WHITENER, VALENTINE, Private, Company E. Mustered December 7, 1861 - May 5, 1862. Discharged by order of Brigadier General Wadsworth.

WICK, RICHARD, Private, Company E. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died August 25, 1864, and buried Andersonville Code 16808.

WIDEL, EUGENE E., Private, Company H. Mustered February 22, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40413. Left prison December 14, 1864.

WILHELM, HENRY B., Private, Company A. Mustered September 16, 1861 - July 19, 1862.

WILHELM, JAMES S., Private, Company A. Mustered September 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40253. Died October 28, 1864, at Florence Prision, South Carolina.

WILLIAMS, GEORGE R., Private, Company A. Mustered March 3, 1864 - June 25, 1865.

WILLIAMS, JACOB, Private, Company H. Mustered February 22, 1862. Transfered to 4th US Artillery Regiment.

WILLIAMS, JOHN, Private, Company A. Mustered September 7, 1861 - February 20, 1863.

WILLIAMS, PETERS, Private, Company B. Mustered August 25, 1862.

WILLIS, JAMES, Private, Company K. Drafted November 29, 1863 - April 10, 1865. Transferred from 165th Pennsylvania Infantry Regiment. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40460.

WILLMAN, FRANK, Private, Company H. Mustered February 22, 1862.

WILLS, JAMES, Company K. Buried at Fairfield-Catholic, Adams County, PA.

WILSON, ANDREW M., Corporal, Company C. Mustered September 16, 1861. Promoted from Private September 16, 1861. Killed In Action, December 14, 1862, during the Battle of Kinston, North Carolina.

WILSON, JAMES MADISON, 1st Lieutentant, Company C. Mustered age 21, September 16, 1861 - June 25, 1865. Promoted to Corporal September 16, 1861; to Sergeant May 1, 1862; to 1st Sergeant July 7, 1862; to 2nd Lietenant January 14, 1863; and to 1st Lieutentant July 1, 1863.

WILSON, JEREMIAH P., Private, Company A. Mustered September 7, 1861 - June 25, 1865. Wednesday morning April 20, 1864, the third day of the Battle Of Plymouth, North Carolina, observed another enlisted man laying wounded Outside of Fort Williams. Although it seemed like certain death to venture above the parapet, without hesitating, he jumped over, grabbed the man, and brought him into the fort by climbing up the parapet. Received a severe wound in the thigh before reaching cover. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 41486.

WILSON, JESSE B., Private, Company C. Mustered August 29, 1864 - June 25, 1865.

WILSON, JOHN, Private, Company E. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40349. Died October 10, 1864, at Florence Prison, South Carolina.

WILSON, NEWTON, Private, Company A. Mustered December 25, 1861. Died August 13, 1862, on transport between Harrison's Landing, Virginina and Philadelphia, Pennsylvania.

WILSON, SAMUEL P., Private, Company H. Mustered February 22, 1862 - March 3, 1865 (Pittsburgh, Pennsylvania). Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40414. Left prison December 20, 1864.

WILSON, WILBUR F., Private, Company D. Mustered age 20, March 15, 1865 - June 25, 1865.

WILSON, WILLIAM A., Private, Company A. Mustered March 3, 1864 - June 25, 1865.

WION, JOHN, Corporal, Company H. Mustered March 23, 1862. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40398. died of Scorb Bronchitis December 29, 1864, in Annapolis, Maryland. Buried at Annapolis National Cemetery, Maryland #D1542.

WION, WILLIAM, Private, Company A. Mustered September 7, 1862. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40252. Died November 24, 1864, at Florence Prison, South Carolina.

WISE, HENRY A., Private, Company E. Mustered December 7, 1861 - May 15, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40348.

WISE, LEWIS, Private, Company K. Mustered age 42, January 12, 1862 - March 31, 1863.

WISE, OLIVER, Private, Company E. Mustered December 7, 1861. Detached service.

WISHARD, ALEXANDER, Private, Company A. Mustered September 7, 1861 (1863). Wagoner. Captured in Plymouth, North Carolina April 20, 1864. Comrade reported that he died December 20, 1864, in Richmond, Virginia.

WOLF, ANDREW, Private, Company D. Mustered August 25, 1862. Died of Congestive Fever March 17, 1863, in New Bern, North Carolina. Buried in New Bern National Cemetery, North Carolina.

WOLF, JAMES, Private, Company B. Mustered September 24, 1861 - December 4, 1861.

WOLF, MATTHIAS, Private, Company D. Mustered November 13, 1862 - April 1862.

WOLFORD, LEWIS, Corporal, Company E. Mustered age 15, December 7, 1861 - January 30, 1865. Hospitalized with chronic diarrhea, fever, and ague, and pain in the side fall of 1863 - April 1864 and granted a furlough of 30 days. Honorably discharged December 7, 1864, as his term of enlistment had expired.

WOODRUFF, WILLIAM D., Private, Company B. Mustered September 24, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died July 16, 1864, and buried Andersonville Code :13384.

WORCHTER, JOHN, Private, Company K. Mustered October 28, 1861. Died at Davis or David's Island, New York August 8 (28), 1862 or July 28, 1862. Remains delivered to relatives.

WRAGG, WILLIAM, Private, Company K. Mustered age 45, December 13, 1861. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40461. Died at Camp Parole, Maryland shortly after parole December 22, 1864.

WRIGHT, JOSHUA H., Private, Company G. Mustered age 37, January 10, 1862.

WYANT, HENRY, Private, Company G. Mustered January 10, 1862. Captured in Plymouth, North Carolina April 20, 1864. Died June 15, 1864, and buried Andersonville Code 11977.

WYANT, JEREMIAH, Private, Company D. Mustered August 30, 1862 - June 25, 1865. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40320. Left prison December 10, 1864.

YOCKEY, JOHN, Private, Company F. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 41551. Left prison December 24, 1864. Died of Typhoid in Annapolis, Maryland January 9, 1865. Buried in Annapolis National Cemetery, Maryland #D1498.

YOUNG, HORACE, Private, Company H. Mustered February 22, 1862. Died at White House, Virginia June 1862.

YOUNG, LOY B., Private/Muscian, Company G. Mustered December 7, 1861. Transferred from Company F January 1, 1862. Captured in Plymouth, North Carolina April 20, 1864. Andersonville Code 40379. Left prison December 7, 1864.

YOUNT, JOHN, Private, Company C. Mustered September 16, 1861. Died of Typhoid May 29, 1862, near Savage Station, Virginia at Rose Cottage Hospital. Buried at Seven Pines National Cemetery, Seven Pines, Virginia.

ZIEGLER, ANDREW, Private, Company E. Mustered age 34, December 7, 1861.

ZIERL (ZIRL), SEBASTIAN, Private, Company F. Mustered December 7, 1861. Captured in Plymouth, North Carolina April 20, 1864. Died August 25, 1864, and buried Andersonville 16818.

ZILEFRO, WELDON S., Corporal, Company F. Mustered December 7, 1861.

ZIMMERMAN, DANIEL, Private, Company H. Captured in Plymouth, North Carolina April 20, 1864 Andersonville 40417. Died October 7, 1864, in Florence Prison, South Carolina.

ZINK, JOSIAH, Captain, Company F. Mustered December 7, 1861 - February 13, 1863. Promoted from 1st Lieutenant to Captain June 22, 1862. Resigned.
